# New Hampshire Businesses SUPPORT YOUR COMMUNITY with CDFA TAX CREDITS







Granite United Way's Whole Village Family Resource Center and Bridge House have received a New Hampshire Community Development Finance Authority (CDFA) tax credit grant in the amount of \$321,875. In addition, the Plymouth Area Renewable Energy Initiative (PAREI) will lend their expertise to guide us through energy efficiency and solar energy efforts. The organizations will:

- Utilize the tax credits for clean energy upgrades at both facilities
- Have project guided by the Plymouth Area Renewable Energy Initiative
- Reduce costs for these facilities will allow the organization to apply more resources toward services for clients
- Monies saved on energy costs will be diverted to the much needed services the facilities provide for families in the Plymouth area community

#### Tax credits must be sold in these increments:

\$160,000 in Year 1 (July 1, 2015 – June 30, 2016) \$161,875 in Year 2 (July 1, 2016 – June 30, 2017)

#### How can your business benefit from this opportunity?

CDFA grants are tax credits, not cash. New Hampshire companies can support this project by purchasing our tax credits. This allows the nonprofit to receive a donation and allows the company to get a 75% state tax credit against that contribution. The credit can be applied against the Business Profits Tax, Business Enterprise Tax, or Insurance Premium Tax.

## **Sample Way to Give Back**

A contributing business that takes a \$10,000 cash investment in this CDFA approved project will receive a state tax credit in the amount of \$7,500. After federal tax benefits are accounted for, the contribution actually costs the company about 11% of the \$10,000, or \$1,100.\*

### **Just four simple steps**

**Step 1:** Pledge to our project (CDFA has specific pledge form available on their website at www.nhcdfa.org

Step 2: Pay off pledge to CDFA

Step 3: Once a contribution is received, CDFA will send the business a federal charitable contribution letter

Step 4: Claim credits on New Hampshire Business Profits Tax, Business Enterprise Tax, or Insurance Premiums Tax

#### Whole Village Family Resource Center an initiative of Granite United Way
