Please have these documents ready for your appointment

\*Social Security or Individual Taxpayer Identification Number (ITIN) for each family member and working adult

\*1095-A if you received a tax credit from healthcare.gov marketplace

\*Childcare provider name, address and tax ID (if applicable)

\*Bank routing and account numbers for checking or savings account (if you qualify for refund via secure direct deposit)


\*Last year's tax return, if you have it (Need Adjusted Gross information)

\*A valid email address

\*W2's, 1099's, 1098's, and other tax forms

Did you know that when your doctor orders labs/blood work you do not have to go to their lab? Did you know that you can save money if you have your labs/blood tests done with an independent lab? ### **DID YOU KNOW?**

Some schools won't consider you for merit scholarships (scholarships based on academic achievement or other talents or skills) until you've submitted a FAFSA, so complete one even if you think you won't qualify for federal aid.

#### **RELAX!**

The FAFSA is designed to be simple to fill out. Tips throughout the application help you understand the questions. Most people finish filling out the FAFSA in less than half an hour!
