FREE Income Tax Assistance

Did your household earn \$66,000 or less in 2018? Save your money and do your taxes online at www.myfreetaxes.com

Angel or Pru can assist you with this process if you need.

Did you know that professional tax prep help can cost hundreds of dollars? This program is FREE! Don't miss out! You will need to have the following items:

- *Social Security or Individual Taxpayer Identification Number (ITIN) for each family member and working adult
- *1095-A if you received a tax credit from healthcare.gov marketplace
- *Childcare provider name, address, and tax ID, if applicable
- *Bank routing and account numbers for checking or savings account (if you qualify for a refund via secure direct deposit)
- *Last year's tax return, if you have it.
- Need Adjusted Gross information
- *A valid email address
- *W2's, 1099's, 1098's, and other tax forms



Don't wait to sign up for Summer Camp!

It's that time of year to start signing up for summer camp. Did you know that you can apply for a camp scholarship that might cover the camp tuition? If you know the camp you would like your child to attend ask the camp for a scholarship application NOW. If you find that you only qualify for a partial scholarship talk to your Work United Resource Coordinator for a referral for Listen's Camp Scholarship Program (kids age 6-14). Referrals begin in February, and self-referrals begin in March. Listen may be able to cover the remainder of your balance, per their income guidelines (extenuating circumstances taken into consideration). If the camp scholarship is covered 100% directly through the camp program, you may still qualify for another scholarship through Listen. If your household participates in any of the following programs you may also meet the guidelines – **Fuel Assistance, WIC, CSFP, TANF, APTD, Food Benefits, Medicaid, OAA, Aid to the Needy & Blind, SSI, Subsidized Housing (Rental Subsidy), County, City or Town Welfare or experiencing homelessness.** If you need any assistance with this process contact your Work United Resource Coordinator.
